PRESIDENT'S NOTE JULY 2024

Resolution (2)

- a) Senior members who have been accorded Senior Membership status under Rule 4.1(g) and entitled to the benefits in Rule 6.4(b) and 6.4(c) may transfer their membership to any of their legitimate children subject to:
 - i) The proposed transferee is acceptable to the General Committee for membership of the Club following the provisions of these Rules relating to the Application for Membership;
 - ii) The proposed transferee pays to the Club, upon election as a member, an administrative fee equivalent to 20% of the prevailing Entrance Fee;
 - iii) The transferee pays the prevailing refundable deposit, while the transferor's deposit shall be refunded;
 - iv) The transferee shall continue to enjoy all the facilities of the Club, subject to applying for a supplementary card for the parent(s) and undertaking to pay all dues incurred by the parent(s);
 - v) Anyone who has ceased to be a member or is undergoing suspension shall not be entitled to transfer their membership until readmitted or the suspension period is completed;
 - vi) The transferor shall not be a proposer or seconder of the transferee.

NOTICE IS HEREBY GIVEN that the Extraordinary General Meeting of the KELAB DIRAJA SUNGAI UJONG (Royal Sungai Ujong Club) will be held at the Club on 28th August 2024 at 10:00 am.

AGENDA

RULE 9.8 Extraordinary General Meetings.

The General Committee may at times by giving at least fourteen (14) days' notice in writing to the members call and convene an Extraordinary General Meeting to discuss and pass in the said General Meeting any resolution or make any amendments to any Rules of the Club Constitution and Bye-Laws and at such EGM (by 50) members shall form a quorum and if the number shall not be present at the expiration of thirty (30) minutes from the advertised time of such EGM, then the EGM shall be postponed to a date seven (7) days from such EGM at the same place and time and no further notice shall be required to be given. Notice of the adjourned meeting shall be posted on the notice board in the Club premises. Should there be no quorum at the postponed meeting the members present thereof shall form the quorum.

- Resolution (1) The objective and subject of this EGM.**
- Recognition and measurement of Stock Machine assets value and its corresponding entry in the Statement of Financial Position and Statement of Comprehensive Income for the current financial year ended 31 December 2023 and
- Formation of assets revaluation of asset value relating to Slot Machine and it's corresponding entries to the financial statements of prior years.

Preamble:

In consideration of the valuation of RM1,00 assigned to the slot machines within the Club's assets, it is necessary to deliberate and approve their inclusion within our financial framework. This valuation holds significant implications for our financial reporting and management strategies, impacting decisions on asset liquidation, operational budgets, and long-term financial planning. As such, a comprehensive discussion is essential to ensure clarity and consensus among stakeholders regarding the treatment of these assets moving forward.

- Resolution (2) That the proposed amendments to Rule 6.A (Amendments in bold).**

Clause 6.4(a)

For Ordinary Members, who are awarded Senior Membership status under Rule 4.2(g), the rate of monthly subscription payable shall be one-half of the rate payable by an Ordinary Member as from the date such status is accorded to him; and

Clause 6.4c)

Senior members who have been awarded Senior Membership status under Rule 4.2(g) and who have attained the age of seventy (70) years shall be exempted from paying the monthly subscription of the Club.

Clause 6.7

Senior members who have been awarded Senior Membership status under Rule 4.2(a) and entitled to the benefits prescribed in Rule 6.4(b) and 6.4(f):-

- may transfer their membership to any of their legitimate children subject to:-
 - if the proposed transferee is acceptable to the General Committee for membership of the Club following the provisions of these Rules relating to the Admission by Membership;
 - if the proposed transferee pays to the Club, upon the election of the proposed transferee as a member, an administrative fee equivalent to 20% of the prevailing Entrance Fee which is charged;
 - the transferee paying the prevailing refundable deposit whereas the transferor's deposit shall be refunded to the transferee;
 - that thereafter continue to enjoy of the facilities of the Club subject to the transferee applying for a Supplementary Card/Cards for the parent/parents and undertaking to pay all fees incurred by the parent/parents to the Club;
 - anyone who has ceased to be a member of the Club or who is undergoing suspension shall not be entitled to transfer his/her membership until he/she has been readmitted or until he/she has completed the period of suspension;
 - the transferor shall not be a proposer or the seconder of the transferee.

Preamble:

The following resolution was approved at the Annual General Meeting (AGM) in April 2024. However, due to unforeseen circumstances, the resolution was not uploaded to the eSPOS system, causing a technical glitch. Therefore, it is being proposed for approval and adoption again at this Extraordinary General Meeting (EGM).
